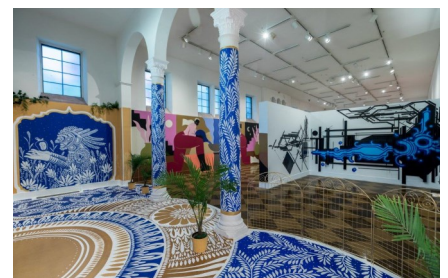

#### *Corbel Communications Industries, LLC*

International network developer, SiFi Networks is currently working on Work Zone 14 in the City of Fullerton building a state-of-the-art fiber optic network. This network is passing every home and business in the City and while privately funded, built, and operated by SiFi Networks, it will be an open access network enabling a choice of internet service providers that could save customers' money. This project once completed will provide a significant upgrade to internet speeds and accommodate a growing demand for data from next generation devices in local households and businesses. It will also facilitate new smart city initiatives in key government services, such as traffic control, street lighting, and emergency services.

This week, SiFi's contractor Corbel Communications completed 4,860 feet of installation throughout Work Zone 14.

### City of Fullerton Sales Tax *Update*

Fourth Quarter Receipts for Third Quarter Sales (July - September 2019)

#### Fullerton In Brief

Fullerton's receipts from July through September were 7.1% below the third sales period in 2018 though the decline was the result of numerous anomalies in payment timing that occurred after the State's recent transition to a new reporting system. After adjusting for the correct allocation period, sales were 1.7% higher.

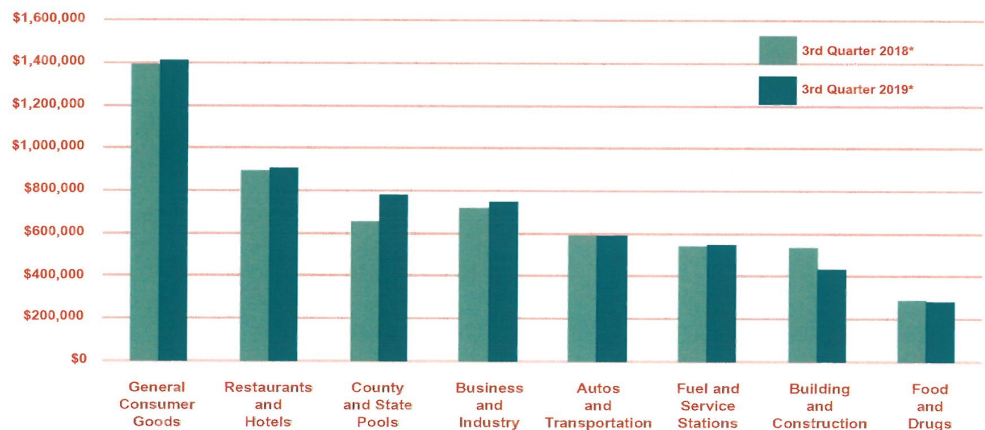
The largest factor in this improvement was a surge in allocations from the countywide use tax pool that has been boosted by the implementation of California's AB 147 legislation as a result of the Supreme Court's recent Wayfair decision. The law, implemented April 1, has established a lower threshold to collect use-tax on internet sales, contributing to a 19% increase in Fullerton's receipts from the pool over the last year.

Quick-service restaurant and textile/furnishing sales were also stronger. Used car sales increased as the record price of new cars has made the plentiful supply of relatively new, off-lease vehicles a strong value proposition for consumers.

The sale of building-construction materials fell, consequently, with the recent closure of a local supplier.

Net of aberrations, taxable sales for all of Orange County grew 3.3% over the comparable time period; the Southern California region was up 2.8%.

### City of Fullerton Sales Tax Update

NOTES

#### Statewide Results

The local one-cent share of statewide sales and use tax from sales occurring July through September was 2.2% higher than the summer quarter of 2018 after adjusting for accounting anomalies.

The bulk of the increase came from the countywide use tax allocation pools and is due to the acceleration in online shopping where a large volume of the orders are shipped from out-of-state.

Online shopping also produced gains in the business-industrial group with in-state industrial zoned logistics centers filling orders previously taken by brick and mortar retailers. Purchases to support healthcare, food processing, logistics/warehouse operations and information/data technology also helped offset declines in other business-related categories.

With the exception of some discount and value-oriented retail, most categories of general consumer goods were down. New cannabis related start-ups offset declines in the food and drug group while a softening in building-construction receipts was consistent with recent declines in the volume and value of new building permit issuances.

Overall growth in restaurant receipts continued to soften with a shift toward lower cost dining establishments and takeout meal options. Reports of labor shortages and the impact of homelessness on customer traffic in metropolitan areas were reportedly factors in the decline in tax revenues from higher price, fine dining establishments.

Despite a slight uptick in used auto and auto lease receipts, the auto related group was significantly down due to a drop in new car and RV sales. Previously propped up by a 23% subprime rated customer base and six- and seven-year financing, loan delinquencies have recently surged back to levels last seen in 2009.

#### Additional Tax Districts Approved

Voters approved eight of the nine sales

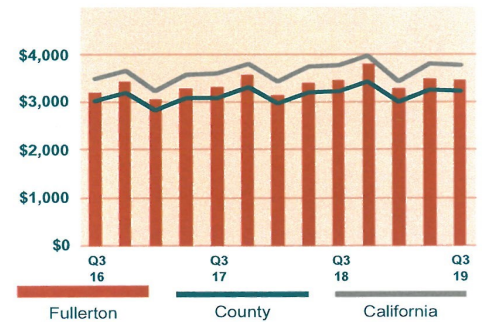
tax measures on the November 2019 ballot adding six new districts and extending two others.

This brings the total number of local transactions and use tax districts (TUT's) to 325 with 62 that are levied countywide and 263 imposed by individual cities. The number of local districts have close to tripled over the last decade as agencies deal with rising costs and service needs. TUT's have been a favorable option as visitors contribute to the tax and a collection system is already in place that minimizes administrative and monitoring costs.

California's basic rule is that the rate for all local TUT's combined, shall not exceed 2.0% or a total of 9.25% including the state levy. However, the state legislature has authorized higher caps in some jurisdictions with the highest voter-approved, combined state/local rate now at 10.5%.

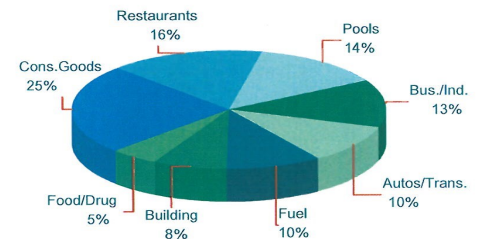
Thirty-five or more additional local TUT measures are currently being considered for the March 2020 ballot.

## Cannabis Information & Listening Session

California voters approved Proposition 64 – The Adult Use of Marijuana Act on November 8, 2016, for the recreational possession, sale and use of marijuana. Due to limited data being available and the complexity and varying degrees of regulation around cannabis-related activities, the City Council provided direction to staff to begin outreach efforts to better understand the community's receptiveness to cannabis-related industries.



On Thursday, February 13<sup>th</sup> the City of Fullerton invited any interested parties to a Cannabis Listening and Information Session. City staff was in attendance to provide background information on Proposition 64, State mandates on the legal use of marijuana, cannabis user trends, health statistics, regulation models and requested feedback from all in attendance on if, where and how marijuana products should be cultivated, manufactured and sold in Fullerton. It is estimated approximately 75 people were in attendance and the City collected over 70 responses from residents and stakeholders.

The City will next be hosting a panel discussion on cannabis led by industry, tax administration and health experts. The Cannabis Panel Discussion will take place Thursday, March 5<sup>th</sup> at 5:30pm at the Grand Hall in the Community Center. ## Water Division Update

On Wednesday, January 29th, a representative from the Water Division responded to 4000 Bonita Place to investigate water seeping from a valve box. The Water Division crew member confirmed the leak originated from the fire hydrant valve. This valve is used to isolate the water flow to the fire hydrant when needed.

In this situation, California Government Code 4216 requires the Utility (Water Division) to call two working days, not including the date of notification, before a planned excavation. After the site was marked, a Water Division construction crew responded to the location to excavate the area and replace the leaking isolation fire hydrant valve. The site of the excavation has been secured, the fire hydrant is back in service, and our Street Division will install permanent asphalt as soon as possible.





## Self-Haulers: Recycling Green Waste

State Law AB 1826 requires businesses and multifamily complexes of five or more units to recycle green waste (leaves, grass clipping, limbs, non-treated wood, and brush trimmings). This means landscapers and gardeners providing services in Fullerton, or those self-hauling their own green waste, are required to compost the green material. ### GUIDE TO ORANGE COUNTY'S HOUSEHOLD HAZARDOUS WASTE COLLECTION CENTERS



**For your safety, please observe the following regulations in preparing for your visit to the HHWCC:**

- Household Hazardous Waste Collection Centers can only accept waste from Orange County residents. Waste will not be accepted from businesses, churches, schools, nonprofit organizations or government agencies.
- A maximum of 15 gallons or 125 pounds may be transported per vehicle, per trip (Department of Transportation Requirement). It is illegal to exceed these limits.
- Containers larger than five gallons will not be accepted.
- Containers will NOT be returned, except for oil containers, upon request.
- Materials must be in original containers (except motor oil, fuels and antifreeze).
- All containers must have lids, be sturdy, non-leaking, labeled and protected from breakage.
- Do not combine different types of waste.
