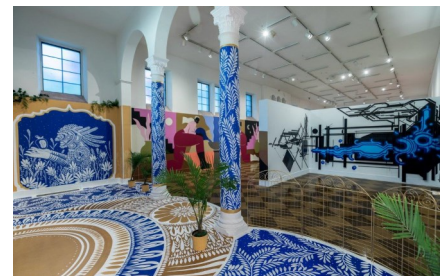

WEEKLY REPORT

International network developer, SiFi Networks is currently working on Work Zone 14 in the City of Fullerton building a state-of-the-art fiber optic network. This network is passing every home and business in the City and while privately funded, built, and operated by SiFi Networks, it will be an open access network enabling a choice of internet service providers that could save customer's money. This project once completed will provide a significant upgrade to internet speeds and accommodate a growing demand for data from next generation devices in local households and businesses. It will also facilitate new smart city initiatives in key government services, such as traffic control, street lighting, and emergency services.

This week, SiFi's contractor Corbel Communications completed 3716 feet of installation throughout Work Zone 14. This includes the rest of Run 15 on S. Pacific Dr. and Run 2 on W West Ave., S. Lee Ave., W. Ash Ave. and W. Oak Ave.

CITY COUNCIL MEETING REVIEW

The City Council met on February 18th with Closed Session beginning at 5:00 pm and Regular session beginning at 6:30pm and concluded at approximately 10:00pm.

The City Council held a Closed Session. There was no report out from the City Attorney.

Pastor Jason Phillips, Sojourners Church, conducted the invocation and Council Member Silva led the Pledge of Allegiance.

There were two presentations.

- ◇ Certificate: Dong Shin Church of Southern California. Peter Chae accepted a certificate for the Parks and Recreation Department donations.
- ◇ Certificate: Rolling Hills Elementary School Teacher Appreciation. The Mayor presented teachers Jodi Dyer and Kim Cleary with a certificate.

Approximately three members of the public made comments to include: homelessness, and an invitation to an upcoming CSUF event.

The City Manager announced the upcoming, newly created Citizens Academy 2020 and explained the program's objectives and goals.

There were no Appointments made.

- Final Consideration of Proposed Side Letter to Memorandum of Agreement between the City of Fullerton and Fullerton Police Management Association. This item was approved 4-1 (Whitaker opposed).

Accessory Dwelling Units & New Employees

Accessory Dwelling Unit (ADU) Regulations

The Planning Commission reviewed amendments to the Fullerton Municipal Code regarding Accessory Dwelling Units at its meeting on February 19th. The State legislature passed a series of bills regarding Accessory Dwelling units which became effective on January 1, 2020. The intent of this legislation is to continue to advance the state's goals to provide housing to accommodate California's growing population and to meet current and future needs for affordable and special needs housing. The proposed amendments to the Fullerton Municipal Code will bring the City's regulations in line with State law and provide clear guidance to property owners wishing to construct an accessory dwelling unit on their property.

New Employees

The Community and Economic Development Department is excited to announce the arrival of two new staff to its Department. **Kellee Fritzal** is joining Team Fullerton as its new Deputy Director of Community and Economic Development. Kellee is coming to Fullerton from the City of Huntington Beach where she served as the Deputy Director in the Office of Business Development. Kellee has extensive experience in running successful Economic Development, Redevelopment, Homeless Outreach and Housing programs at other cities where she worked previously. She is a Fullerton native and is very excited to come back and serve a City she knows so well. In her role as Deputy Director, Kellee will be primarily overseeing the Housing Division while also growing the City's Economic Development functions. Economic Development has been a major area of interest for the City Council so having Kellee onboard to help lead that initiative will be a huge benefit to our department and the City as a whole.



Also joining the Community and Economic Development Department as an Administrative Analyst is **Lauren Yoon**. Lauren previously worked for the City of Stanton in that City's Business Licensing Department. As an Administrative Analyst, Lauren will be focusing on developing and administering the department's budget, contract management and department analytics. One of the first tasks that Lauren will be taking on will be managing the second floor lobby remodel, which will include new furniture, flooring, paint and counter height reconfiguration to expand the seating capacity of the lobby and generally improve the customer experience. Lobby remodeling will occur on closed Friday's and weekends to not interrupt public counter hours. Also included as part of the Lobby Remodel will be the introduction of an electronic queuing system for the public counter. This web-based system will replace the old manual customer sign-in and will automatically track customer volumes and wait times. The new system will also let customers check current wait times online to see how long they may have to wait before they arrive at City Hall. This new queuing system along with the Department's goal to expand the number and type of permits that can be applied for online are expected to substantially reduce customer wait times at the public counter. The 2nd floor lobby remodel is scheduled to start in May, and be completed by June.

GUIDE TO ORANGE COUNTY'S HOUSEHOLD HAZARDOUS WASTE COLLECTION CENTERS



For your safety, please observe the following regulations in preparing for your visit to the HHWCC:

- Household Hazardous Waste Collection Centers can only accept waste from Orange County residents. Waste will not be accepted from businesses, churches, schools, nonprofit organizations or government agencies.
- A maximum of 15 gallons or 125 pounds may be transported per vehicle, per trip (Department of Transportation Requirement). It is illegal to exceed these limits.
- Containers larger than five gallons will not be accepted.
- Containers will NOT be returned, except for oil containers, upon request.
- Materials must be in original containers (except motor oil, fuels and antifreeze).
- All containers must have lids, be sturdy, non-leaking, labeled and protected from breakage.
- Do not combine different types of waste.

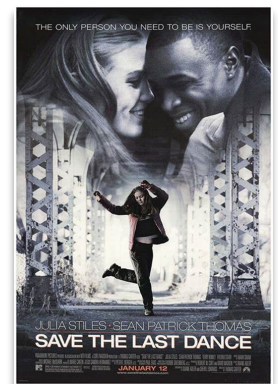



DID YOU KNOW...

Early Fullerton History

Like many postcards printed during the era, this 1910 photo of children swimming in an irrigation ditch was used for promotional purposes. Eager to attract more settlers, local



residents showcased Fullerton as a good place to raise children and a town where water was plentiful for farming.
