City Manager's Message

Phone Scams

Fullerton PD recently had contact with a resident who was the unfortunate victim of a fraud/theft. The victim received a phone call and the person told her that her social security number had been compromised and in order to fix it, she needed to go to her bank and withdraw all but \$10,000 and to make a cashier's check payable to the scammer and to send the cashier's check (by overnight delivery) to an address in Comstock Park, Michigan. The victim followed the instructions and sent the cashier's check. Our Police Officer contacted Kent County Sheriff's Deputies who ultimately contacted the recipient of the cashier's check at the address the check was sent. The scammer told deputies that he did in fact receive the cashier's check and deposited into his bank account. He also admitted he was supposed to then send the money to a contact in Ghana. The recipient was determined not to be the person who called the victim and ultimately the money is in the process of being returned to this victim. This victim was fortunate that the money was returned. This was due to excellent, quick and thorough investigation by our Police Officer. Great job!

As a reminder, PLEASE do not fall victim to phone scams and DO NOT send money if someone tells you that your information has been compromised. If you are suspicious, do not hesitate to contact the Police Department, at 714.738.6800.

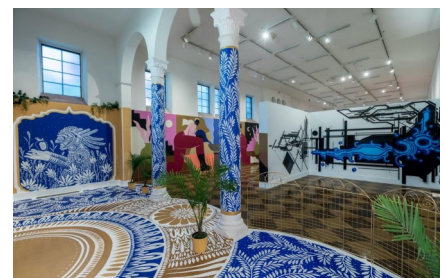

International network developer, SiFi Networks is currently working on Work Zone 14 in the City of Fullerton building a state-of-the-art fiber optic network. This network is passing every home and business in the City and while privately funded, built, and operated by SiFi Networks, it will be an open access network enabling a choice of internet service providers that could save customers' money. This project once completed will provide a significant upgrade to internet speeds and accommodate a growing demand for data from next generation devices in local households and businesses. It will also facilitate new smart city initiatives in key government services, such as traffic control, street lighting, and emergency services.

This week, SiFi's contractor Corbel completed 6,582 feet of installation throughout Work Zone 14 which included the remaining parts of Run 12 on W Southgate starting from the intersection of Eadington Ave. to the Intersection of Lambert Dr. And Run 13 starting on Lambert Dr. which from the intersection of Lambert Dr. and Porter Ave., North to Oak Ave. and from Oak Ave East to S. Basque Ave. and S. Basque Ave. South to Porter Ave.

CITY COUNCIL MEETING REVIEW

The City Council met on February 4th with Closed Session beginning at 5:00 pm and Regular session beginning at 6:30pm and concluded at approximately 10:00pm.

The City Council held a Closed Session. There was no report out from the City Attorney.

Pastor Israel Gomez, Branches Church, conducted the invocation and Mayor Pro Tem Flory led the Pledge of Allegiance.

There was one presentation.

◇ Proclamation: Career Technical Education Month. Michael Le, Technology and Facilities Management Director, and Tonia Watkins, Human Resources Director, with North County ROP made a presentation.

Approximately four members of the public made comments to include: permit parking for RV, Community Choice Energy Program, urban forestry, and homelessness.

The City Manager announced new employee hires, and stated he is working with staff on a memo regarding the energy program which will be brought before the City Council at a future date.

There were no Appointments made.

The Consent Calendar:

- Appropriation of Donations or Gifts. This item was discussed and approved as amended, to bring back before the City Council an annual or semi-annual report, at the discretion of staff. This item was approved unanimously.
- The remainder of the Consent Calendar items was approved unanimously.

Public Hearing Item:

- New 33-Unit Residential Development at 751 East Bastanchury Road. The resolutions for this item were approved. This item was approved 4-1 (Whitaker opposed).

Water Division Update:

On January 29, a representative from the Water Division responded to 2632 Tiffany Place to investigate water seeping from beneath the street. The Water Division crew member confirmed the leak was from the water infrastructure, and the area was secured and marked for Underground Service Alert.

In this situation, California Government Code 4216 requires the Utility (Water Division) call two working days, not including the date of notification, before a planned excavation.

On Monday, February 3, the area was excavated and a new one inch copper water service was installed. During the water service replacement, an additional leak developed on the water main approximately four feet from the location of the new water service. This new leak was repaired and the water main was placed back into service the same day. The area of the excavation has been secured and is prepared for the installation of hot asphalt by our Street Division. The street will receive permanent asphalt repairs as soon as possible.

Parking Lot Maintenance

The City owns approximately 50 parking lots that service our downtown, parks and public buildings. Annual lot maintenance keeps our parking lots attractive and safe. Our in-house Public Works employees are experts in providing excellent parking lot repairs and are dedicated to serving the community with courteousness and professionalism. The crew recently repaired the asphalt and seal coated a large portion of the Fullerton Santa Fe Depot parking lot located at 120 East Santa Fe Avenue.

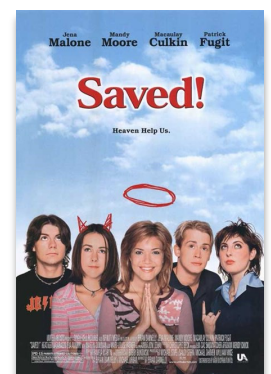

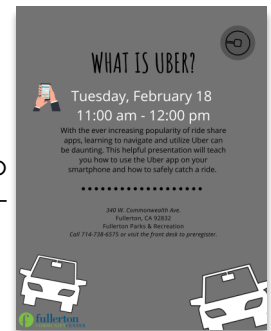

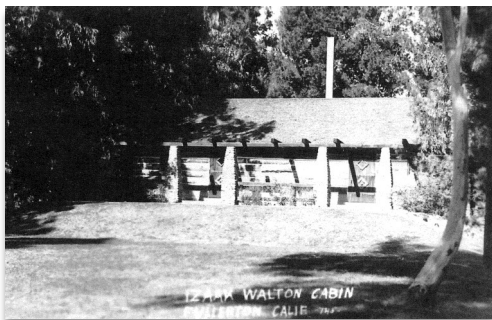

Early Fullerton History

Centrally located in Hillcrest Park, the Izaak Walton Cabin was constructed of discarded telegraph poles in 1931 at a cost of \$165. WPA workers later added the stonework seen in this 1940s photo.

A fire on December 24, 1990 destroyed the original cabin, but it was reconstructed in 1996.
