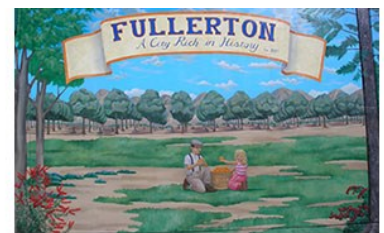

Downtown Active Transportation Plan

The Community and Economic Development Department received a grant from the Southern California Association of Governments (SCAG) for the preparation of an Active Transportation Plan (Plan) for the Downtown and surrounding neighborhoods. The plan will develop preliminary designs, analysis and recommendations to provide open and easy access to and around the Downtown for walking and bicycling for recreation or commuting, and will identify improvements to the active transportation network for non-motorized transportation connecting neighborhoods, activity centers (including schools and parks), employment, and transportation hubs like the Fullerton Transportation Center and bus depot. The Plan will specifically aim to improve mobility for people walking and biking by providing a comprehensive plan for active transportation that includes bicycle elements, pedestrian elements, Safe Routes to School (SRTS) elements, connections to transit and major destinations in the area as well as supporting elements such as amenities and wayfinding signage.

The resulting Plan will identify needed improvements for non-motorized transportation connecting neighborhoods, activity centers (including schools and parks), employment centers, and transportation hubs which the City will then utilize to pursue construction grants to implement. The City Council-appointed Active Transportation Committee will have a pivotal role in the development of the Plan and will serve as the City's stakeholder advisory group in addition to direct outreach to the Downtown businesses, property owners and residents. Consultant selection is scheduled to begin the week of January 20th and an anticipated project kick-off in March of this year. Development of the Plan is projected to take 12-18 months.

Raymond/Chapman Aves. Safety Enhancements

On December 3, 2019, Raymond Elementary School hosted a Community Forum to discuss traffic safety concerns at the intersection of Raymond Avenue and Chapman Avenue. Representing the City were Traffic Engineer Mark Miller and Lt. Jon Radus of the Police Department's Traffic Bureau. Fullerton Union School District (FUSD) Risk Manager Laurie Bruneau, Principal Yolanda McCome, and FUSD Assistant Superintendent Dr. Chad Hammit were also in attendance.

The community and parents of Raymond Elementary students expressed concern for motorist and pedestrian safety at the intersection. Specifically, there is concern regarding the east/west left-turn movement from Chapman Avenue onto Raymond Avenue. Existing traffic signal left-turn phasing at the intersection consisted of east/west "permissive" green ball indications. The permissive phase allows a motorist to make the left turn when a gap in opposing traffic exists.

In conducting an accident analysis, staff determined that "protective" left turn phasing was warranted due to the number of left-turn accidents brought about by violations of right-of-way. Protective left-turn phasing forces opposing traffic to stop while left turning drivers are afforded a "protected" left-turn arrow. The City's signal maintenance contractor made said operational changes on December 23rd while school was out of session.

In addition, "All-Red" signal timing was added to the overall timing sequence. The purpose of the all-red interval is to allow vehicles which have legally entered the intersection prior to the onset of the red signal to clear any potential points of conflict before the release of opposing vehicles or pedestrians.

The Police Department's Traffic Bureau will continue to monitor traffic operations and issue citations as necessary to re-educate those drivers who continue to disregard basic traffic laws; i.e. speeding and/or vehicle right-of-way compliance.

Lastly, but equally relevant, is the effort the FUSD puts forth in addressing concerns on campus; e.g., loading/unloading practices, parent behavior, and safety measures. Their "Go Human" campaign, a program of community enlightenment focusing on student safety, has been and will continue to be an integral part of educating both students and parents on good safety practices near our schools.

In all, the three E's (Engineering, Enforcement & Education) have been put into play to reduce the margin for conflict and enhance both pedestrian and motorist safety.

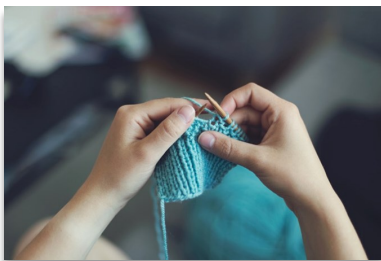

DID YOU KNOW...

Early Fullerton History

Cotton shortages caused by the Civil War prompted Domingo Bastanchury to purchase land in the mid-1860s and develop the largest herd of sheep in the area. In this 1890s photo, Bastanchury sheep are being herded through downtown Fullerton to the train station. The ranch in northern Fullerton was later converted to what has been called the largest orange grove in the world.
