## City Manager's Message

### Increased Parking Enforcement City-wide Approved

The City Council approved a contract amendment with SP+, the City's current contractor for Downtown paid parking enforcement. The amendment will now provide for city-wide parking enforcement by SP+ to include overnight parking, day-time parking restrictions, and street sweeping violations. The City has attempted to staff internally through Parking Control Officers and part-time Parking Control Assistants through the Police Department, but we were having difficulty filling the positions. The use of a contract provider allows us to enforce parking restrictions and be flexible with our budgeting needs.

### New Policy on Discontinuation of Water Service

The City Council approved a new policy to address the Discontinuation of Residential Water Service due to the enactment of Senate Bill 998, approved by the Governor in 2018. The intent of the legislation is to provide residential account holders adequate notice and time to pay outstanding water charges prior to discontinuation of water services for non-payment. The key components of the Act (and resulting Policy) require that the water utility provide:

- residential customers notice that their account is delinquent;
- sixty (60) calendar days after the account is delinquent to pay outstanding charges;
- additional notice at least seven (7) business days prior to discontinuation of water services;
- for those residential customers who meet certain conditions, the ability to enter into one alternative payment arrangement at a time; and,
- for those customer below 200% of the poverty line, a limit on the reconnection fee and an annual waiver of late charges.

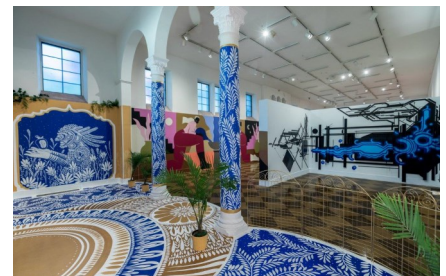

### SiFi Networks and Fullerton FiberCity



International network developer, SiFi Networks is busy working in Work Zone 14 in the City of Fullerton building a state-of-the-art fiber optic network. This network is passing every home and business in the City and while privately funded, built, and operated by SiFi Networks it will be an open access network enabling a choice of internet service providers that could save customers money. This project once completed will provide a significant upgrade to internet speeds and accommodate a growing demand for data from next generation devices in local households and businesses. It will also facilitate new smart city initiatives in key government services, such as traffic control, street lighting, and emergency services.

Last week SiFi's contractor Corbel completed 8,373 linear feet of installation throughout Work Zone 14 which included S. Lee Avenue, W. Porter Avenue, S. Orchard Avenue, S. Basque Avenue, and W. Orangethorpe Avenue.

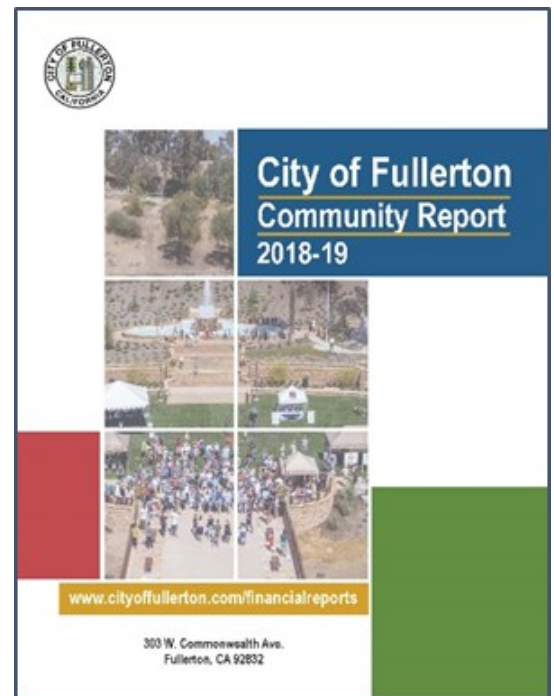

Final Consideration of Tentative Agreements between the City of Fullerton and Fullerton Municipal Employees Federation and between the City of Fullerton and the Fullerton Management Association. Agreements reflect tentative wages, hours and working conditions by the City Council.

Municipal Advisory Services and Debt Refundings. This report provides an overview of the City's existing debt issuances and opportunities for refinancing. City staff seeks authorization to obtain municipal advisory services and to refund the City's 2005 Tax Allocation Bonds (TABs). The 2005 TABs were issued by the former redevelopment agency and the interest rate is over 5%, making the refunding of these bonds viable due to very low interest rates. Due to the dissolution of the former redevelopment agency, the refunding (or in other words, buying new bonds at a lower interest rate for the remaining term of the current issue) will benefit all of the taxing entities that receive property tax from the former redevelopment agency, including our local schools. Projections for increased property tax returns for K-12 education is \$368,000 a year, or almost \$3 million over the remaining life of the bonds. For the City, there could be up to \$125,000 additional property tax annually.

First Consideration of a Proposed Side Letter to the Memorandum of Agreement between the City of Fullerton and the Fullerton Police Management Association. This is being presented for first review by the City Council.

## Water Division Updates

On Monday, January 20, members from the construction section of the Water Division responded to a leak in the street at 1708 Baronet Place. The responding members secured the site and marked the area for Underground Service Alert. California Government Code 4216 requires, in this situation, that the utility owner (Fullerton) call Underground Service Alert two working days prior to the planned excavation. This is to ensure the location of the underground utilities within the excavation area is identified for the safety of the repair crew and to minimize the chance of damaging the utilities.

On Thursday, January 23, a repair crew from the Water Division responded to the location and replaced the existing leaking water service with a new copper water service. The water service is the conveyance method for water delivery from the main to the residential water meter.

Upon completion of the water service replacement, the excavation was backfilled and secured; the Street Division scheduled the installation of hot asphalt for January 30.





## Helicopter Association International HELI-EXPO

The Helicopter Association International (HAI) brought the international HELI-EXPO show to the Anaheim Convention Center, January 28-30, 2020. All helicopters on display staged out of Fullerton Airport. We had approximately 40 helicopters during this time frame and sold between 4,000 – 5,000 gallons of jet fuel during the week.



## Fullerton Airport as a future Uber Elevate Portal?

At the HAI Heli-Expo, one of the seminars was on Urban Air Mobility and the future it plays in reducing traffic and congestion. The City's Airport Director and City Manager attended to hear from industry experts to include the FAA, Uber, Bell Helicopters, and others about the future of electric vertical takeoff and landing aircraft (eVTOL). The goal of eVTOL is to provide quiet, clean, efficient and effective transportation utilizing available assets. This includes piloted and remote piloted all electric aircraft that would bridge short destinations and reduce commutes that could be up to two hours down to 15 minutes or less. 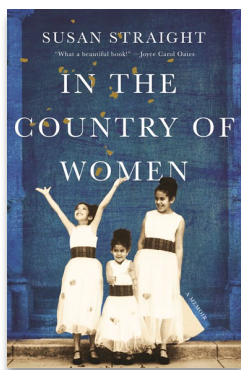
