**REQUIREMENTS FOR FILING APPLICATION FOR CERTIFICATE OF COMPLIANCE**

The following must be submitted with completed application. (All Certificates of Compliance submitted ***must be*** prepared by a Registered Civil Engineer that is authorized to practice land surveying or a Licensed Land Surveyor of the State of California.)

1. Three copies of a written legal description of the property involved, as it currently exists and the County Assessor Parcel Number.
2. Three copies of a sketch or map (to be drawn on 8-1/2" x 11" form, other sizes permitted upon approval by City staff) of the property involved, showing the following information:
  - a) North arrow and scale.
  - b) Existing lot lines with dimensions, bearings and other appropriate boundary information. A traverse of the parcel must close within a 100<sup>th</sup> of .01 feet.
  - c) The adjusted parcel shall be lettered with the original lot or parcel numbers and/or letters. The net acreage of the parcels shall be shown, to the nearest one-thousandth of an acre.
  - d) The location and direction of flow of any natural or improved drainage paths, pipelines or swales; the location (if known) of sewer laterals and water and gas lines, and meters; and the location of any utility lines, poles and easements.
  - e) The location of the properties in relation to adjoining and nearby lots, streets, alleys and easements.
  - f) Existing contours or topography if required by the Director of Public Works.
  - g) Any other information relevant to the area and its improvements which would help in the consideration of the Certificate of Compliance request.
3. The location of existing easements, buildings, garages, fences, etc., and other permanent improvements shall be shown on Exhibit "C" with their relation to the lot lines.
4. A copy of a recent title report (no more than 3 months old) and all underlying documents to the property involved in the Certificate of Compliance.

**NOTE**

Upon favorable consideration of the application, a formal **Certificate of Compliance Approval Certificate** will be prepared by City staff using the above information. Prior to approval by the City, the Certificate must be signed by all of the vested record owners of the property involved. These signatures, which must be notarized, signify the owner's consent to and approval of the Certificate of Compliance as described in the Certificate. Following final approval by the City, the Certificate, including the legal description and map of the property will be returned to the applicant's engineer for recordation with the Orange County Recorder.
