



RESIDENT ONLY PERMIT PARKING PETITION

We the undersigned property owners request that the City of Fullerton consider

our petition for "Resident Only" permit parking on _____

between _____ and _____

We understand the following:

- It shall be unlawful for any person to stand or park any vehicle on any street or portion thereof, while the permit parking is in effect, unless a parking permit issued by the City is displayed on the vehicle as provided for in this section.
- Participation in the permit process is optional; however, vehicles without said permit will be prohibited from parking on the street between the hours of 7:00 a.m. to 7:00 p.m., Monday through Friday. The following holidays are exempt for Residential Permit Parking: New Years Eve, New Years Day, Martin Luther King Day, Lincoln's Birthday, Presidents Day, Washington's Birthday, Memorial Day, 4th of July, Labor Day, Veterans Day, Thanksgiving Day and the immediate Friday thereafter, Christmas Eve, and Christmas Day, as well as General or Special Election days.
- Resident Only Permit Parking does not exempt a vehicle from Section 8.44.080 of the Fullerton Municipal Code pertaining to "Early Morning Parking" between 2:00 a.m. and 5:00 a.m.
- This restriction shall not apply to any authorized emergency vehicle, City or Government vehicle, public utility vehicle or service vehicle when used for official business or performing a private service on said permitted street, or to any vehicle used for the collection or delivery of United States Mail.
- Only non-commercial passenger vehicles or pick-up trucks owned and registered to any resident of a single-family property are eligible to utilize permits. **Commercial, recreational, inoperative, or unregistered vehicles are prohibited from acquiring and/or utilizing residential parking permit(s).**

- A \$10 annual issuance fee shall be assessed per household upon participation in the permit program, regardless of the number of permits issued.
- A \$2.00 fee shall be assessed for each permit issued (Maximum 5 per household).
- The maximum assessed to any participating property is \$20.00, but may be less. Fees, administrative or other, shall not be charged to residents who do not request permits.
- All parking permits issued by the City pursuant to this section shall be valid for the one year period from January 1st through December 31st of each year.
