Governor Newsom Orders Bars Closed, Inside Dining Curtailed

Due to increased numbers of positive COVID-19 cases and deaths from the disease, Governor Newsom has rolled back some of the re-openings in counties which have seen larger increases. All bars are to be closed for at least three weeks.

Restaurants must close their indoor dining as well, however, take-out and outdoor dining is still allowed and encouraged. The City has encouraged local restaurants to utilize outdoor dining as a way to stay open and continue to employ people - as well as provide awesome food for us all! Increased use of outdoor sidewalks, patios, and even parking lots have been put in place to help restaurants replace indoor dining that is not able to be used. The City also closed down a portion of Wilshire Avenue to

create an outdoor dining experience, Walk on Wilshire, for adjacent restaurants. Take a look and explore, but most importantly, wear a face covering and help support our local businesses!



Your Actions Save Lives

Every person has a role to play. Protecting yourself and your family comes down to common sense: Staying home except for [essential needs/activities](#) following local and [state public health guidelines](#) when patronizing approved businesses. Issuance and Sale of 2020 Tax Allocation Refunding Bonds and Approving Necessary Documents in Connection Therewith

A proposed resolution of the Successor Agency to the Fullerton Redevelopment Agency (Successor Agency) to authorize the issuance and sale of Tax Allocation Refunding Bonds, Series 2020 A & B (collectively 2020 Bonds) and approve necessary documents and authorizing certain other actions in connection therewith, and a proposed resolution of the Fullerton Public Financing Authority (FPFA) authorizing the execution of an Escrow Agreement for City Council consideration.

The City Council was provided an overview of the City's outstanding debt obligations with an analysis of what debt made sense to refinance on February 2, 2020. Based on direction from that meeting, Staff brought back an item on May 19, 2020 to begin the selection of the financing team to refund Tax Allocation Bonds originally issued in 2005. At this time, the refunding potential of adding in the 2010 Housing Tax Allocation Bonds will bring additional savings to all of the taxing entities. Both of these bonds have their principal and interest payments paid for through former property tax increment provided to the Successor Agency to the former Redevelopment Agency. By refunding the bonds at a lower interest rate (much like refinancing your home mortgage at a lower interest rate) there will be smaller debt service payment required and more property tax can be returned to the various taxing entities that should receive the normal distribution of property tax, to include schools. The City portion is a about 15.64% which equates to an increase of property tax to the City of about \$230,000 a year.

Placement of a Ballot Measure for a Sales and Use Tax Measure for Public Consideration at the November 3, 2020 General Municipal Election and Preparation of Associated Documents Thereto

Consideration of the placement of a transaction and use (sales tax) tax measure on the November 2020 General Election ballot. The City Council must adopt a Resolution to place the proposed sales tax measure on the November 3, 2020 ballot as well as introduce the Ordinance that will be before the voters.

This item is recommending that the City Council place a 1.25% (or 1.25 cent) sales tax measure on the November, 2020 General Election ballot for voter consideration. Based on the City's ongoing financial condition, the demand for services to includes increasing our responsiveness to homeless issues, the need to make significant improvements to our streets, roads, sidewalks and other public infrastructure issues, and after many reviews and the realization that the City budget cannot be fiscally sustainable under its current revenue generation, the City Council will debate whether to place this measure before the voters for approval. The proposed increase would be a general tax, which means that it can be used for general operations of the City. A general tax measure requires a voter approval of 50% +1 at the election. Professional Services Agreement for Communication and Outreach Efforts Related to Sales Tax Measure

Request to award a professional services agreement to Terris Barnes Walters Boigon Heath, Inc. (TBWBH Strategies) for communication and outreach efforts if the City Council approves a sales tax measure for the November, 2020 General Election.

If the sales tax measure described above is approved to be on the General Election ballot, it is a secondary recommendation of Staff to approve an agreement with TBWBH in order to assist the City to effectively educate the residents about our financial conditions and to make sure that all information and communication does not violate any prohibition against using City resources to advocate for ballot measures. The proposed contract is not to exceed \$125,000 depending on the amount of mailed information provided to residents.

Summary of Commercial Cannabis Community Outreach Efforts and Recommendations Regarding a Draft Commercial Cannabis Ordinance

City Council consideration and recommendations regarding Municipal Code Amendments pertaining to commercial cannabis activities within the City.

This item is the culmination of several years of discussion over whether to allow cannabis related activities, such as cultivation, manufacturing, testing, and retail dispensaries. First considered by the City Council in June, 2016, the issue was most recently presented to the City Council on October 15, 2019 and direction was given to hold a series of community forums on the issue. A draft ordinance is included as part of the consideration in order to get final direction, if provided, and that would start the formal public process to include a Planning Commission meeting before coming back to the City Council for consideration of an actual ordinance. Water Division Updates

Meter Shop

Meter Shop staff perform meter reading duties and respond to service calls during normal hours of operation and callouts after hours. In addition, they also turn water services on or off based on residents' needs, post water service accounts, replace water meters, water meter boxes/lids and perform repairs/tests on water meters.

Water Production

Staff perform a variety of field lab sampling as required by the state of California. This includes water samples from our wells, reservoirs and water distribution system. Control valves and plug valves regulate water between different pressure zones or elevations within the water system and require preventative maintenance (PM). Well production is a total of gallons produced from City water wells, and MWD production gallons reflect water purchased from Metropolitan Water District.

Water Distribution

This Division is responsible for the maintenance of the water transmission and distribution system that delivers water to City residents, businesses, and industries. The water transmission and distribution system consists of 430 miles of water pipeline, more than 31,500 metered services, 4,000 fire hydrants, and 12,000 valves. On an annual average, we respond to 4,600 underground service alert tickets.

Offered through a partnership with Second Harvest Food Bank, this program offers a free, nutritious meal to youth members of local communities under the age of 18. Meals are available Monday-Friday from 4:00 - 5:00 PM at the Maple Neighborhood Center, located in Lemon Park at 701 S. Lemon Street, 92832. Through our partnerships, we have been able to provide 7,680 seniors with food and other essential services.

The Fullerton Community Center is meeting the needs of the community by distributing free groceries to over 350 seniors and families in need each week through our partnership with Second Harvest Food Bank. Groceries are distributed every Thursday from 1pm to 3pm and we are currently operating as a drive-up service to allow for social distance and safety guidelines. **Please note: starting July 9th we will be distributing produce boxes only. Second Harvest will be discontinuing the shelf-stable boxes.**

Special thanks to the generosity of the Consulate General of the Republic of Korea in Los Angeles, in partnership with Assemblywoman Sharon Quirk-Silvas's office, for donating masks to assist our senior community. These donations are an effort to increase personal protective equipment for our elderly community and will be distributed to our senior patrons.

- When you arrive at your scheduled time, please pull into one of the marked Curbside Pickup Slots. Please call the Circulation desk and staff will come out with your items (the phone number will be displayed by the pickup area).

If you have a trunk, please open your trunk and staff will put your items within the trunk. 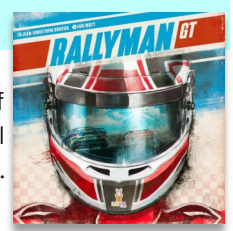

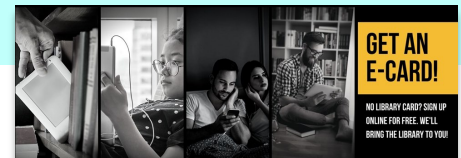
