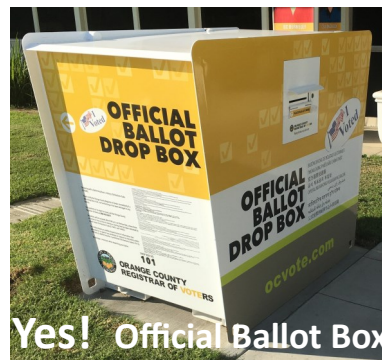

Trick or Treat! ? Yes!

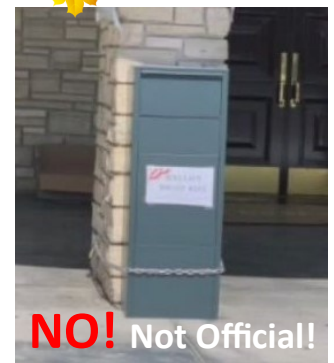

Question: Can the City seek grants to make road repairs?

A: Not for traditional road repairs such as potholes, slurry seal, grind and overlays, or street reconstructions. Those are considered maintenance and OCTA, State, and Federal grants are not available for those activities. What the City does seek and get grant funding for is when we are adding to a street such as a new turn lane or widening an arterial street. Additionally, such as on the next Council meeting, the City has been very successful in obtaining grants to increase the flow of traffic on a street such as synchronizing traffic signals and getting new equipment for the signals. Some grants, as when we turned Wilshire into a "Bike Boulevard," allow us to also repave the street, but in general, street maintenance, specifically for residential streets, is a pure City maintenance responsibility and must be done with our own funds.

Fullerton is a full-service city with its own police and fire departments, so emergency responders are close by and available to keep Fullerton a great, safe place to live, work and raise a family. We take pride in the quality of life in our city; however, like all cities, Fullerton is facing challenges.

Q. What challenges does the City of Fullerton face?

A: Fullerton is an older city, facing several challenges, including a significant increase in 911 emergency calls, a homelessness problem, and many local roads in critical need of repair. The City's revenue base hasn't kept pace with the cost of protecting and maintaining our city and addressing these challenges. The current pandemic and its impact on our local economy has only exacerbated the situation. Although the City has cut costs and reduced positions and services, additional funding is necessary to avoid further cuts in services.



Q. What is Measure S?

A: In recent years, the City has taken a number of steps to maintain a transparent and open government while controlling costs to ensure efficient services for all residents. In order to repair streets, maintain public safety and other community services, the Fullerton City Council voted to place Measure S, a 1.25% local sales tax, on the November 3, 2020 ballot.

All funds raised by Measure S would stay in Fullerton and could not be taken by the State or County. Essentials like groceries and prescription medicine would be exempt from Measure S.

Q. When will Measure S appear on the ballot?

A: Measure S will appear on the November 3, 2020 General Election ballot. All registered voters within the City of Fullerton are qualified to vote on Measure S. If you are currently not registered to vote, contact the Orange County Registrar of Voters at (714) 567-7600.



Q: Does Measure S require fiscal accountability?

A: Yes. Measure S requires a citizens' oversight committee and public reports. Visitors to Fullerton would contribute to the cost of maintaining and improving our city. 100% of Measure S funds would remain in Fullerton and could not be touched by the State or County.

How to Dispose of Sharps Safely and Legally

What to Do with Used Sharps in California

Put used sharps in a strong, plastic container.

When the container is 3/4 full, put the lid on, seal it with duct tape, and label DO NOT RECYCLE.



In California, it is illegal to place containers of used sharps (needles, syringes, lancets, auto injectors, infusion sets, connection needles) in household trash. Please place them in a strong plastic container, like an empty laundry detergent or bleach bottle, seal it with duct tape and label "DO NOT RECYCLE" and bring it to one of HHW Centers listed below. Water Division Updates

Meter Shop

Meter Shop staff perform meter reading duties and respond to service calls during normal hours of operation and callouts after hours. In addition, they also turn water services on or off based on residents' needs, post water service accounts, replace water meters, water meter boxes/lids and perform repairs/tests on water meters.

Water Production

Staff perform a variety of field lab sampling as required by the state of California. This includes water samples from our wells, reservoirs and water distribution system. Control valves and plug valves regulate water between different pressure zones or elevations within the water system and require preventative maintenance (PM). Well production is a total of gallons produced from City water wells, and MWD production gallons reflect water purchased from Metropolitan Water District.

Water Distribution

This Division is responsible for the maintenance of the water transmission and distribution system that delivers water to City residents, businesses, and industries. The water transmission and distribution system consists of 430 miles of water pipeline, more than 31,500 metered services, 4,000 fire hydrants, and 12,000 valves. On an annual average, we respond to 4,600 underground service alert tickets.

Water Repair & Water Quality

On September 6, a repair crew from the Water Division was sent out to 1503-1505 Welldow Lane to replace two 1-inch HDPE (plastic) water services lines. The crew installed twenty feet of 1-inch copper and a new 1-inch angle ball valve to each unit. The excavation was backfilled with base and temporary asphalt material to grade. The Street Division will make permanent repairs to the roadway as soon as possible.



Water Quality Specialist

The Water Quality Specialist monitors routine and main break bacteriological results and takes action if a positive sample is detected. Per California regulation, water services that present a hazard to the water supply are required to have a backflow prevention device to prevent polluted or contaminated water from entering the potable water system. These devices must be tested yearly to ensure they are in working order. The Water Quality Specialist is also responsible for water conservation complaints and assists in responding to billing disputes.

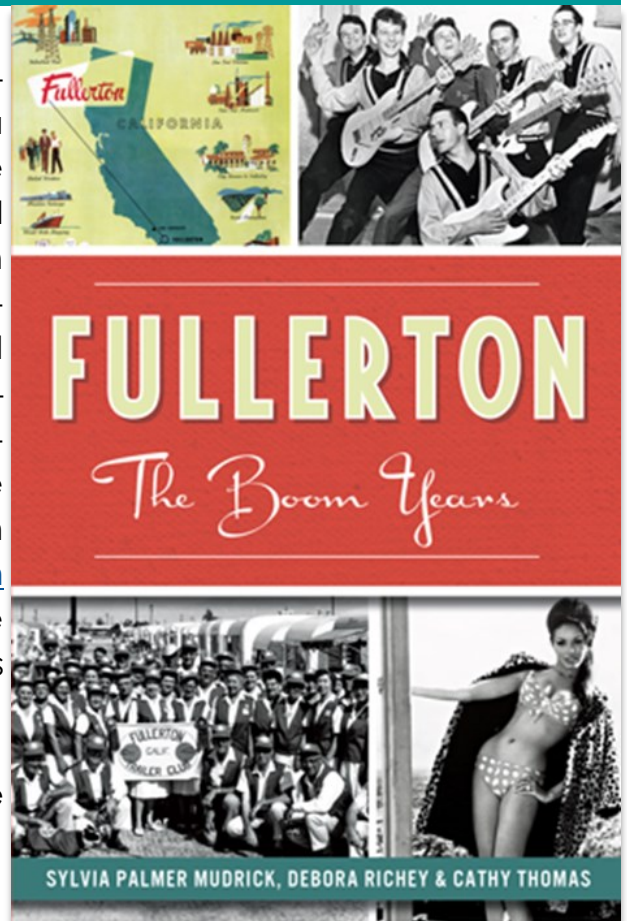

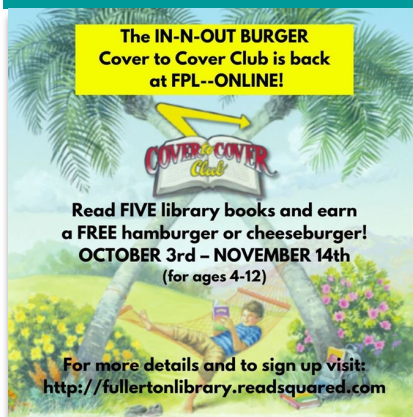

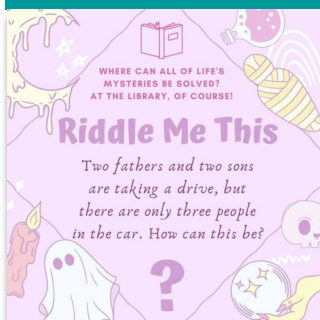

Watch Now! OnLine Holds Are Available For Curbside Pick-Up!



Place holds directly in our [catalog](#)! Check out our new video tutorial above. (Click on it!)

Here's how it works: When you place items on hold, library employees will pull the available items from the shelves and process them for pickup. Once the hold becomes available, you will receive an automated notification by email or phone that the items are ready. You can also check your holds status online via your account at www.fullertonlibrary.org under the "Holds" tab in "My Account."

Once you have been notified that your items are ready, call the library Monday through Friday from 11:00 a.m. to 4:00 p.m. at (714) 738-6333 to make an appointment to pick them up. You will have 14 days from the time of notice to pick up your materials. (If you can't call, send us an email at info@fullertonlibrary.org.)

Due to high demand, the library requires a minimum of two to three full business days to process requests. (During this time there may also be a slight delay in our ability to reach out to you by email or phone.) We ask you to be patient as we work hard to fulfill your requests while taking extra precautions, including quarantining returned books for 96 hours, to ensure your safety.

Returns are not accepted during curbside pickup. To return your items, please use the outdoor book drop between Monday at 9:00 a.m. and Friday at 4:00 p.m.

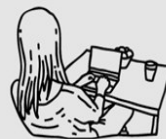

5 SCHEDULE YOUR PICKUP

Call the library at (714) 738-6333 to schedule your pickup. (Press "0" to access the Curbside Pickup menu.) Available by appointment only.



6 WEAR A MASK

Wearing a mask, come to the Curbside Pickup area by the main entrance of the library. If we don't come out to you, please call us.



7 ENJOY YOUR ITEMS!

Take your items to go and enjoy! Items can be returned to our automated book drop between Monday at 9:00 AM and Friday at 4:00 PM.
