What Are the Next Steps for New Councilmembers?

So you are elected to City Council... what now? Newly elected City Councilmembers will begin to meet with City Staff to start to be brought up to speed on many issues, including meeting with the City Attorney's Office to overview the City's current status on litigation and begin fully understanding all of the legal requirements of being a Councilmember to include the Brown Act, Public Records Act, and all things involving conflict of interest and similar requirements. The City has also produced a City Council Handbook that overviews the City organization and practices, but it is by no means a substitute for the many meetings that new members will take part in to meet City Staff and learn first-hand the specific issues upon which they will now have policy control over as members of the City Council.

After December 1st, the City Council webpage will be updated with the new Councilmember information and contact information, including City Council email addresses, will be published, and the new City Councilmembers will have business cards for handing out.

While not successful in their races, I want to thank the following residents for going through with the task of running for City Council: Aaruni Thakur, Andrew Cho, Mackenzie Chang, Chuck Sargeant, and Dr. Faisal Qazi. The time and effort in running for Council is more than anyone understands. Thank you for looking to serve the City of Fullerton.





State Issues New COVID-19 Health Orders

On Monday, the State issued new orders and put Orange County into the most restrictive "Purple Tier" of the Governor's pandemic response plan. Because we are now in the Purple Tier, all indoor dining is prohibited. Outdoor dining is still allowed and very encouraged to help keep our restaurants open! On Thursday, the Governor, through the Department of Public Health, issued a new Health Order that institutes a curfew from 10 PM to 5 AM for all counties within the Purple Tier, including the County of Orange. The order states:

"...all gatherings with members of other households and all activities conducted outside the residence, lodging, or temporary accommodation with members of other households cease between 10:00pm PST and 5:00am PST, except for those activities associated with the operation, maintenance, or usage of critical infrastructure[1] or required by law. This order does not apply to persons experiencing homelessness. Nothing in this order prevents any number of persons from the same household from leaving their residence, lodging, or temporary accommodation, as long as they do not engage in any interaction with (or otherwise gather with) any number of persons from any other household, except as specifically permitted herein."

The City of Fullerton and the Fullerton Police Department encourage all businesses to comply with the order through an education-first approach. We ask your cooperation in order to ensure that our Officers are available for emergency calls for services to our entire community and are able to respond swiftly and effectively in time of true need. As you can imagine, with our diminished resources at the Police Department, which includes less than 120 of our budgeted 140 positions filled, our need is to proactively patrol the City and to respond to emergency 911 calls. Your cooperation helps prevent the spread of the virus and maintains our ability to respond to true emergencies in our City.

What Can I do as a Resident to Support our Businesses?

Fullerton COVID-19 CARES Act Programs Win Award!

The City's business friendly response to the pandemic and its use of County and State CARES Act funding earned the top award for Business Retention and Expansion from the Orange County Business Council's **Turning Red Tape into Red Carpet** Business Awards program. The OCBC lauded our efforts to issue free outdoor dining permits, the issuance of over \$1,116,000 in business grants, our emergency rental assistance, and Feed Fullerton program. Way to Go!





CITY COUNCIL MEETING REVIEW

During the COVID-19 pandemic, the City Council and all City Commissions/Committees may conduct meetings via video conferencing, per exemptions allowed under the Governor's Executive Order N-29-20. All agendas can be found online by clicking [here](#). Comments on agenda items can be e-mailed before the meeting to cityclerksoffice@cityoffullerton.com. Council meetings are also broadcast live on [Channel 3](#), Facebook Live, and streamed online.

The City Council met on November 17th with Closed Session beginning at 4:30pm and Regular session beginning at 6:30pm and concluding at approximately 10:00pm.

Rabbi Nico, Temple Beth Tikvah, gave the invocation. Mayor Fitzgerald led the Pledge of Allegiance.

There was no report out from the City Attorney on Closed Session items.

There were two (2) presentations made: A Certificate of Appreciation was presented to the Veterans Day Committee for their continued work and dedication to Veterans and wished them much success in the years ahead. A second presentation was made by Global Hope 365 to "End Child Marriage Under 18, No Exceptions" Law.

Various e-comments were submitted regarding City issues, such as street sweeping concerns, support on CCE, and support on End Child Marriage Under 18, No Exceptions law.

Many e-comments were submitted on agenda item 17, Commercial Cannabis Activities. E-comments were summarized and read aloud, both in support and opposition.

There were approximately 25 public comments regarding support and opposition to cannabis, Covid, and Community Choice Energy.

Deputy City Manager, Antonia Graham, provided an update on the Governor's Order resulting in Orange County moving back to the Purple Tier. Information will be pushed out on the City's social media platforms outlining the County's new restrictions and guidelines. Effective immediately, outdoor only for dining and gyms; wedding receptions are banned; places of worship must revert to virtual or outdoor services; hair, and nail and personal services may occur indoor with modifications;. The City's website and social media will provide updates as we receive them. Also, last week the City had a very successful homeless outreach and identified 10 hot spots. Over 125 homeless residents were placed into shelters. The number of homeless individuals on our streets has started to decrease. Newly hired employees were announced as well as three employees who successfully completed and graduated the CSUF Leadership Program.

The Tuesday, November 17, 2020 City Council was held in the Council Chambers.

Social Distancing and Face Covering requirements were in effect for members of the public. Limited public capacity was available in the Council Chambers and additional overflow was available. In person Public Comments were allowed but e-comments and emailed comments were highly encouraged.

Consent Calendar Items:

- ◇ Item #4: Industrial Logistics Center at 2001 E. Orangethorpe Avenue (Goodman Logistics Center Fullerton) Zoning Amendment and Development Agreement—Second Readings of Ordinances. This item was pulled and discussed. The item was approved 4-1 (Whitaker opposed).
- ◇ Item #6: Support For Actions to Further Strengthen Local Control. This item was pulled and discussed. This item was approved 4-1 with amendments (Whitaker opposed).
- ◇ Item #9: Fiscal Year 2019-20 and 2020-21 Administrative Budget Amendments and Preliminary Fiscal 2019-20 Unaudited Financial Reports. This item was pulled and discussed. The item passed unanimously.
- ◇ Item #15: "End Child Marriage Under 18, No Exceptions" Law. This item was pulled and discussed. The item passed unanimously with amendments from Mayor Pro Tem Flory.

The remainder of the consent calendar was approved unanimously with the exception that Item #5, the Second Reading Ordinance No. 3293 – Community Choice Energy Program passed 4-1 with Whitaker opposed.

There was one (1) Public Hearing Item.

- Fullerton Municipal Code Amendments Relating to Noise Regulations and Standards. Staff requested to continue this item to date uncertain. On a unanimous vote, this item will be continued.

Regular Business Items:

- Item #17: Code Amendments Pertaining to Regulation of Commercial Cannabis Activities Citywide—Second Reading of Ordinance. The item was discussed and a Motion to Continue was moved by the Mayor, seconded by Councilman Whitaker. That motion failed 2-3 (Flory, Silva, Zahra opposed). After further discussion, another vote was taken to adopt the ordinance which passed 3-2 (Fitzgerald, Whitaker opposed). The ordinance will become effective in 30 days from the date of adoption. A message from the Office of Director of Public Affairs and Government Relations Citrus Pest & Disease Prevention Program

As the California Department of Food and Agriculture (CDFA) continues to fight to protect the state's \$3.4 billion citrus industry, it's calling upon the help of a small, but mighty predator called *Tamarixia radiata* – a parasitic wasp.

These beneficial wasps are being released in several California neighborhoods to reduce the population of the Asian citrus psyllid (ACP), the pest that spreads the deadly citrus tree disease, Huanglongbing (HLB).

This natural biological control is one of the many tools CDFA uses against HLB as the disease continues to be detected throughout the four Southern California counties of Los Angeles, Orange, Riverside and San Bernardino. Although HLB has not been found in a commercial citrus grove, more than 2,000 residential citrus trees in California have been infected with HLB and destroyed.

Water Division Updates

Meter Shop

Meter Shop staff perform meter reading duties and respond to service calls during normal hours of operation and callouts after hours. In addition, they also turn water services on or off based on residents' needs, post water service accounts, replace water meters, water meter boxes/lids and perform repairs/tests on water meters.

Water Production

Staff perform a variety of field lab sampling as required by the state of California. This includes water samples from our wells, reservoirs and water distribution system. Control valves and plug valves regulate water between different pressure zones or elevations within the water system and require preventative maintenance (PM). Well production is a total of gallons produced from City water wells, and MWD production gallons reflect water purchased from Metropolitan Water District.

Water Quality Specialist

The Water Quality Specialist monitors routine and main break bacteriological results and takes action if a positive sample is detected. Per California regulation, water services that present a hazard to the water supply are required to have a backflow prevention device to prevent polluted or contaminated water from entering the potable water system. These devices must be tested yearly to ensure they are in working order. The Water Quality Specialist is also responsible for water conservation complaints and assists in responding to billing disputes.

Water Distribution

This Division is responsible for the maintenance of the water transmission and distribution system that delivers water to City residents, businesses, and industries. The water transmission and distribution system consists of 430 miles of water pipeline, more than 31,500 metered services, 4,000 fire hydrants, and 12,000 valves. On an annual average, we respond to 4,600 underground service alert tickets.

Water Division Emergency Response

On November 9th, a repair crew from the Water Division was sent out to 1784 Island Drive to replace a 1-inch HDPE (plastic) water service line. The crew installed 15 feet of 1-inch copper and a new 1-inch angle ball valve. The excavation was back-filled with base material to grade and secured with barricades and caution tape. The Street Division will make permanent repairs to the roadway as soon as possible.

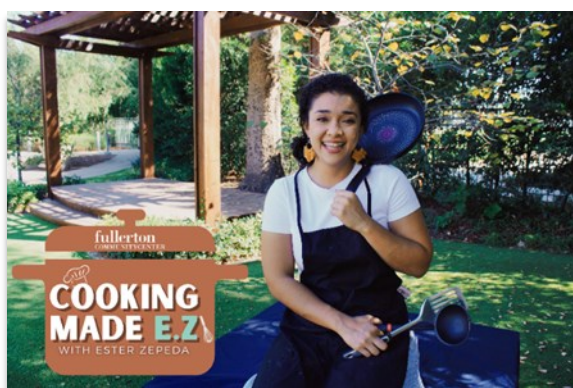

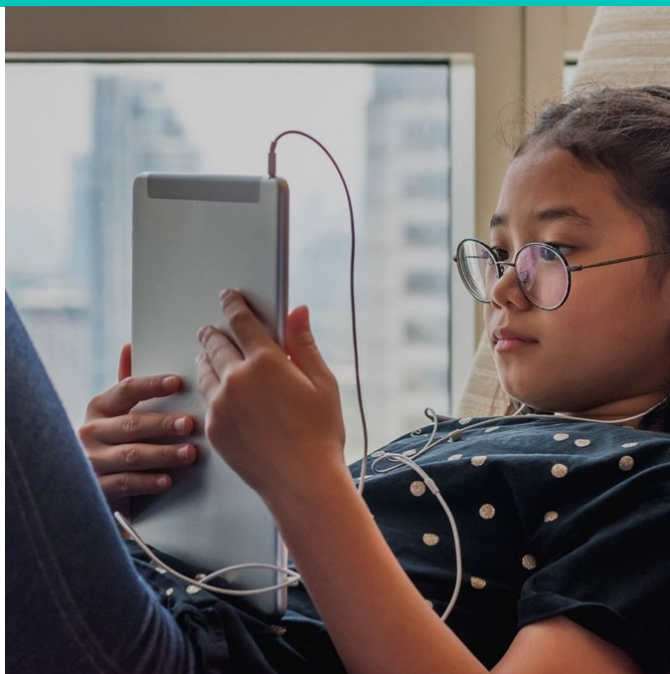

Place holds directly in our [catalog](#)! Check out our new video tutorial above. (Click on it!)

Here's how it works: When you place items on hold, library employees will pull the available items from the shelves and process them for pickup. Once the hold becomes available, you will receive an automated notification by email or phone that the items are ready. You can also check your holds status online via your account at www.fullertonlibrary.org under the "Holds" tab in "My Account."

Once you have been notified that your items are ready, call the library Monday through Friday from 11:00 [a.m.](#) to 4:00 p.m. at (714) 738-6333 to make an appointment to pick them up. You will have 14 days from the time of notice to pick up your materials. (If you can't call, send us an email at info@fullertonlibrary.org.)

Due to high demand, the library requires a minimum of two to three full business days to process requests. (During this time there may also be a slight delay in our ability to reach out to you by email or phone.) We ask you to be patient as we work hard to fulfill your requests while taking extra precautions, including quarantining returned books for 96 hours, to ensure your safety.

Returns are not accepted during curbside pickup. To return your items, please use the outdoor book drop between Monday at 9:00 a.m. and Friday at 4:00 p.m.
