OC ANIMAL CARE UPDATE

On **Thursday, October 19th**, City staff attended OC Animal Care's quarterly meeting. During the meeting, OC Animal Care announced the filing of two new key positions: a Shelter Services Manager and a Business Administrator. OC Animal Care has also been keeping track of their various pilot programs such as **Kennel Connection** and **Sittin' With Kittens** and they have decided to keep these programs going through the fall so that they can continue to gather data on the success of these programs and whether they result in an increase in adoptions. OC Animal Care's foster program has been very successful with 1,751 kittens, 43 dogs, and 97 puppies participating in the program this year so far. OC Animal Care has received over \$120,000 in donations this year and plans to use those funds to add a chicken coop, an outdoor potable water system, and they are currently in plan check for approval of a new shade structure. From July-September, OC Animal Care responded to 18,506 calls for service with an average response time of 20 minutes per call.

OC Animal Care was at Fullerton's Recreational Rider Info booth on September 18th, and will be at the Fullerton Employee Safety Fair on October 25th and the City's Halloween OctoBOOfest on October 26th.

Catch that phish!

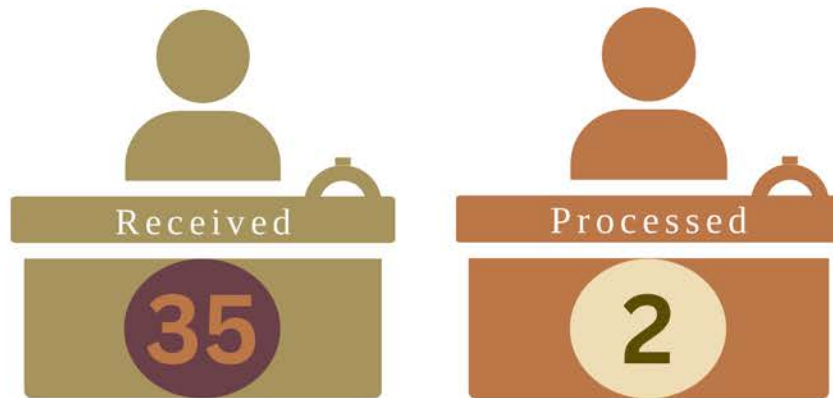
In September, IT saw a 90% increase in the number of users that correctly reported the monthly simulated phishing email, the best score since May. We also saw a decrease in the number of users that failed the phishing test, which was a tie with our best score ever. **Great work identifying and reporting the potentially harmful message!**

Reporting suspicious messages using the PhishAlert button in Outlook alerts the Security Team, who can then investigate and, if needed, remove the harmful message from the mailbox of other users that may also have received it. Thank you to all City staff for their continued diligence and vigilance in keeping our City safe.

The City Clerk's Office received 35 public records requests and processed 2 public records requests, between October 19th and November 2nd, as required under the **California Public Records Act**.



INFORMATION TECHNOLOGY **CONTINUED**

New Copier/Printer Devices Deployed:

Over the past few months, 26 new multifunction copier/printer devices have been installed at various City departments. The new Konica Minolta units replace older devices from various manufacturers. The devices print in color and have a much lower cost per copy than other printers. Using the Secure Print feature, a print job can be sent but will not be printed until the sender badges into the device, preserving confidentiality. Consolidating these devices on one lease centralizes maintenance and provides a cost advantage compared with the previous arrangement.





On November 9th, the City of Fullerton will host a Flip-the-Switch ceremony to celebrate the City's energy savings project with NORESKO, the contractor for the project.

The project has upgraded critical building and energy system infrastructure while delivering economic and environmental benefits to City of Fullerton residents. Among other building and system improvements, the project includes new solar energy infrastructure (pictured above) and new dual port electric vehicle chargers at City Hall for public use, and new dual port electric vehicle chargers at the Police Department for fleet use.

The City of Fullerton contracted with NORESKO, a national leader in energy efficiency, resiliency, and infrastructure solutions, in 2022 to implement an \$8.4 million energy efficiency project guaranteed to save \$12.1 million during the contract period. Funded entirely from generated savings, the project demonstrates that energy savings can help local governments tackle deferred maintenance while also expanding smart city technologies and energy resources.

The ceremony will include Mayor Fred Jung, Fullerton City Councilmembers, Fullerton officials, staff members, and representatives from NORESKO. The event will conclude with a ceremonial flipping of a switch to symbolize how the project helps the City progress toward its climate and sustainability goals.

PLANNING

The public review period for the Initial Study for the Housing Incentive Overlay Zone (HIOZ) closed on October 9, 2023 completing a 30-day review period.

Additionally, the related public Scoping Meeting was held on September 28, 2023. Noticing for this process included publishing in the OC Register, posting on the City website, posting in three public locations, posting on the State Clearinghouse website, and sending approximately 400 emails to agencies and individuals who requested notification. To date, staff received six comment letters from individuals and agencies, which will be incorporated into the Draft Environmental Impact Report (EIR) as necessary.

CODE ENFORCEMENT

Sidewalk Vendor Enforcement:

The City and Orange County Health Sidewalk Vendor Enforcement Task Force's efforts over the past months have resulted in reduced complaints to both agencies and reduced unpermitted taco vendors by 90%. Code Enforcement, Public Works, and PD Staff continue to collaborate with Orange County Health to address any unpermitted sidewalk taco vendors by providing education and enforcement. At this time, only one unpermitted sidewalk taco vendor was observed at the last inspection. The team will also work on addressing complaints received by restaurant establishments reporting unpermitted hot dog vendors in the Downtown area. Coordinated, random sidewalk vendor inspections will continue through the end of December 2023.

Code Enforcement Program Staffing:

As of October 30, 2023, one of three Code Enforcement vacancies was filled by Code Enforcement Officer Frank Bautista. The Division is happy to welcome Frank to the team. Frank is a Certified Code Enforcement Officer who will be a real asset to the team. Frank will provide service to residents and businesses in Zone 2, which is the center of town between Euclid and Raymond. The Code Enforcement Division will continue to work with HR to fill the remaining two vacancies for the citywide Code Enforcement Program.

**Cannabis Enforcement**

At the City Attorney's direction, Code Enforcement staff must follow the Public Nuisance Hearing Process to close illegal cannabis businesses which means that it can take six-ten months to close. Most recently, City staff has been successful at obtaining information to demonstrate illegal businesses that are repeat offenders and who have moved to another location in the City. With that evidence, our City Prosecutor has obtained expedited abatement warrants. The Code Enforcement team has also been working closely with the California Department of Cannabis Control (CDCC) to coordinate efforts.

On October 10th and October 17th Code Enforcement, assisted by the Building Division and Police Department, closed two illegal cannabis dispensaries, one at 1837 West Orangethorpe and the other at 709 West Commonwealth. Both times, the CDCC was able to obtain warrants to enter and confiscate cash and products. After the state agency concluded its warrant, the City executed a court order to terminate power and red-tag the buildings to abate the unpermitted land use and close down the illegal businesses.

City staff will continue with efforts to close the remaining four illegal businesses: 1110-1112 East Ash Avenue, 816 East Chapman Avenue, 2437 and 2439 East Orangethorpe Avenue, and 2142 East Orangethorpe Avenue.

Sidewalk Vendor Enforcement

Due to the task force between Code Enforcement, Public Works, the Fullerton Police Department, and the Orange County Health Department, unpermitted sidewalk food vendors have reduced by 90%. Staff will continue to coordinate random inspections through the end of December 2023.

Recruitment:

The Planning Department is looking to fill three positions: Senior Planner, Associate Planner, and Assistant Planner. To date, the City has received 90+ applications, and staff has been reviewing them to move qualified applicants on to panel interviews before the end of the year.

Streetlights Mixed-Use Project:

The Streetlights mixed-use project at the northwest corner of Orangethorpe Avenue and Lemon Avenue has changed ownership. The new project owner, TDC Properties, will be finishing the building plan check portion and will be finalizing an affordable housing agreement with the City within the next several weeks.

115-121 N. Harbor Blvd.:

Technology company DreamHost, LLC, has begun interior clean-up of their building at 115-121 N. Harbor Blvd. The building, used by Mo's Music for years, will be upgraded to create workspace, offices, and an event space. The new owners of the property have been engaging with Planning staff to work through review and entitlement procedures.

Noise Ordinance:

Staff will be presenting the Noise Ordinance changes to the Planning Commission on November 8, 2023 and, if approved, November 21, 2023 to City Council for adoption.

Clean California Transit Program:

Following a competitive statewide review, Fullerton has been awarded \$799,000 in grant funding for the Transit Center Enhancement Project through the Clean California Transit Program. This project aims to deliver beautification and rehabilitation work to the transportation center, improving quality of life for our residents and community. Project deliverables selected for funding include improvements such as station area rehab, landscaping enhancements, wayfinding, new bike racks, and more.

Coffee Meetups:

Our November Coffee Meetups will be on November 3rd at Fraise Café and Intentional Coffee on November 17th. We encourage businesses to follow our [Eventbrite page](#) and City of Fullerton Instagram page to stay up to date on events and upcoming coffee meet-ups.

SolarApp+:

Over 898,048 participants participated in the ShakeOut in California this year. That includes schools, local and county governments, individuals, medical families, and especially the City of Fullerton. Each year the city has participated we have increased systems being tested and exercised.

In addition to the Drop! Cover! Hold! Earthquake drill the City of Fullerton:

- tested an updated alert and warning system for all city staff
- tested county emergency processes
- and participated in continued readiness training with city staff

On October 14, 2023, Fullerton Fire Department hosted a **LISTOS Emergency Preparedness** class in Spanish. The 8-hour certificated class teaches basic emergency preparedness to residents, workplaces, and employees. On October 20-22, 2023, three staff members Fullerton Police Dept. Community Liaison Officer, Jasmine Valadez Cruz, Fullerton Fire Department, Fire Prevention Specialist Jose Alarcon, and Emergency Manager Kristi Batiste participated in a 24-hour certificated LISTOS Train the Trainer (TTT) class. Having internal trainers will enable the City of Fullerton to host additional trainings in English, Spanish, and in the future, Korean.

Fullerton Library Awarded Building Forward Library Facilities Improvement Program Grant

Following a rigorous evaluation process, the State Library recently announced that the Fullerton Library was awarded the Building Forward Library Facilities Improvement Program Grant (Round Two)! Eligible capital projects include addressing critical maintenance needs, improving energy efficiency and sustainability, and expanding access digitally and physically. This Round Two Grant funds projects at the Main Library is for \$778,055 with required matching funds of \$389,027 which will be provided from the Foundation's and Friends' Restricted Accounts in a 50-50 split. Last year the Library received Building Forward Library Facilities Improvement Program Grant (Round One) which funded improvements at Hunt Library with a grant award of \$194,650 and matching funds of \$194,650 provided by the Fullerton Public Library Foundation. The Building Forward Grant includes the following improvements to the Fullerton's main library:

1. Elevator Renovations (Two Elevators)
2. Osborne Auditorium Renovation (Stage, Lighting, Carpeting)
3. Young Adult Library Area Renovation (ADA Access, Carpeting, Site Prep)
4. Children's Library Area Renovation (ADA Access, Carpeting, Site Prep)
5. Generator Replacement
6. Stairwells (Carpeting Replacement)
7. Osborne Auditorium Room A (Site Preparation, Demolition)

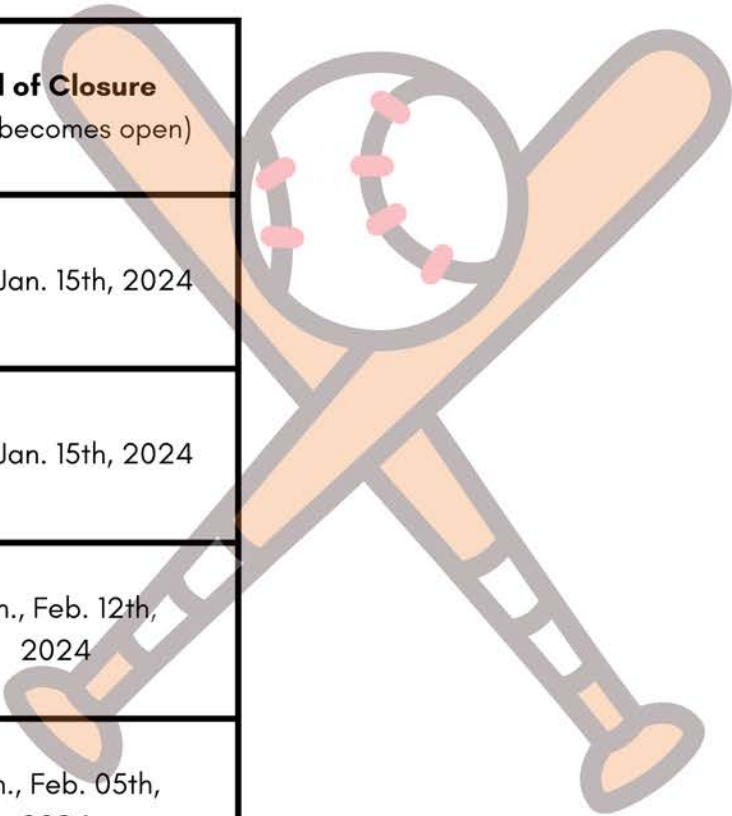
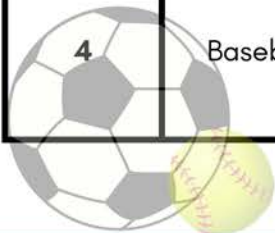

SOLID WASTE AND RECYCLING

The Solid Waste and Recycling (SW&R) is reevaluating the initial Scope of Work for the CalRecycle SB 1383 Local Assistance Grant Program for FY 2021-22 to ensure that the \$197,528.00 awarded funds are used eligibly and productively by the May 2, 2024, Grant Term date. An open dialogue has been established with the Grant Manager, and the amended Budget Detail will be submitted by the end of October 2023 to move forward in a thoughtful and expeditious manner.

Additional SB 1383 Local Assistance Grant Program funding has become available for FY 2023-24. The awarded grant funds for the City of Fullerton are estimated to be \$252,763.00. City staff has started the application and is set to submit the grant funding request by the November 15, 2023, deadline. Grant funds are to be awarded March 2024 with an April 1, 2026, Grant Performance Period. Attention will be aimed to possible Collection, Education and Outreach, Procurement Requirements, and/or Recordkeeping projects.

SOLID WASTE AND RECYCLING CONTINUED

Solid Waste and Recycling Operations and SB 1383 Compliance Update:

Fourth Amendment contract negotiations with Republic Services continue on and have been reimagined to include an additional future Fifth Amendment specifically related to amending the Multifamily sector billing and rate structures. A phased SB 1383 implementation plan is being considered with rollout of recycling and/or organics collection services to begin with Single-Family Home Residences, then followed by Commercial Businesses, and Multifamily Residences lastly.

City staff has made significant efforts to meet with newly appointed Republic Services Executive Management and Operations personnel to build partnering work relationships, discuss current substandard performance issues, and confirm a plan of action to ensure compliance with the City's Solid Waste Handling Services Agreement. Continued monitoring of the waste hauler's weekly performance levels will be regulated to ensure a high standard of operations.

The City's SB 1383 CalRecycle Corrective Action Plan (CAP) compliance efforts continue to advance favorably. The Solid Waste and Recycling (SW&R) Team submitted the Fullerton CAP #3 Report by the State's September 30, 2023, deadline. An extension request for five (5) of the Tasks was also included in the report submission which the State approved. The SW&R Team attended the Fullerton CAP Bimonthly meeting on October 26, 2023, to discuss progress in meeting the CAP deadlines. The State's Enforcement Branch Representative was pleased with the task improvements and felt confident in the City's direction towards implementation.



FULLERTON TRAFFIC COUNTS

The **California High-Speed Rail Authority (CHSRA)** continues to work on moving the Los Angeles to Anaheim Project Section forward. As part of the environmental process, CHSRA is conducting traffic counts in Fullerton. Intersection counts will take place between 6-9am and 4-7pm and roadway segment Average Daily Traffic (ADT) counts will be taken for a 24-hour period both on a Tuesday, Wednesday, or Thursday during a week while schools are in session and without any major holidays. Intersection counts and roadway segment ADT counts will be taken by video recording. Wherever possible the traffic counter will avoid setting up cameras in right of way. Vehicle classification for roadway segment ADT counts will also be recorded.

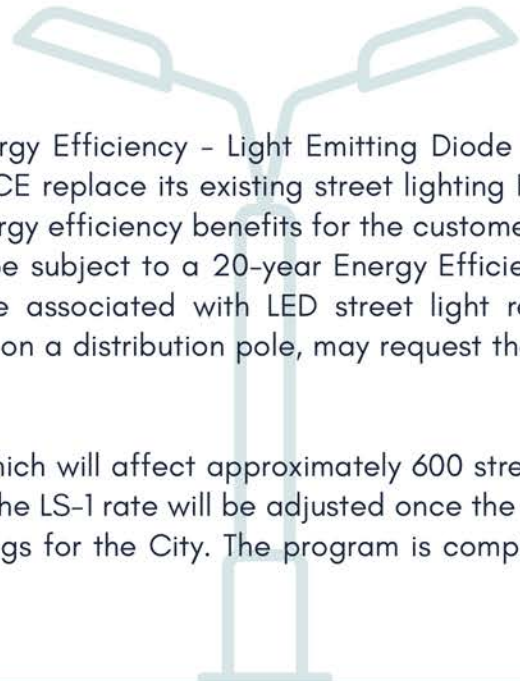

LED STREETLIGHTS

Southern California Edison's (SCE's) LS-1's Option E, Energy Efficiency - Light Emitting Diode (LED) Fixture Replacement, is available to customers who elect to have SCE replace its existing street lighting HPSV fixtures with more efficient LED street lighting fixtures to achieve energy efficiency benefits for the customer. Customers must sign an agreement to qualify for this Option and will be subject to a 20-year Energy Efficiency Premium Charge designed to recover the initial capital expenditure associated with LED street light replacements. Eligible customers with street lighting lamp fixtures mounted on a distribution pole, may request the Distribution Pole Mounted Discount.

The City has elected to execute the Option E Agreement, which will affect approximately 600 street lights that are owned by SCE, which the City pays a flat LS-1 rate for. The LS-1 rate will be adjusted once the LED fixture is installed, which is estimated to result in a \$30k annual savings for the City. The program is completely funded and administered by SCE.



LEAK DETECTION PROGRAM

The **Water Division** contracted the Municipal Water District of Orange County (MWDOC) to conduct a leak detection survey of Fullerton's water distribution system to help identify any water loss throughout the city.

MWDOC's leak detection program has helped identify thousands of leaks through Orange County. The acoustic leak detection equipment used by MWDOC can identify leaks before they surface, shorten their runtime, avoid collateral property damage, and save hundreds of gallons of water per year.

Fullerton's leak detection survey started on **October 9, 2023** and will span 80 miles by the completion of the survey. During the first week of the leak detection survey, MWDOC identified 18 potential leaks in our distribution system. These leaks range from drips at the water meter to small leaks on the customer's service line.

The Water Division plans to further investigate these leaks and notify customers of the potential leaks.
