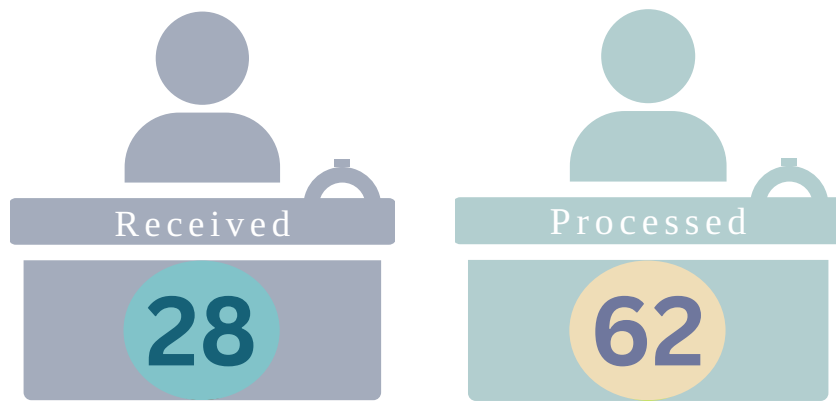

REQUESTS FOR PROPOSALS

INFORMATION TECHNOLOGY

First Tabletop Exercise Conducted

IT and City leadership recently participated in our first tabletop exercise (TTE). A TTE is like a fire drill for how the City would respond to an information security event, such as a ransomware threat or email compromise. During the TTE, the incident response plan was reviewed as the scenario developed and new threats were introduced. The ensuing discussion provided an opportunity to consider how internal and external communications would be handled, what external parties would need to be contacted, and so forth. TTEs are a recommended best practice for information security, and more exercises will be scheduled in the coming months. We take this opportunity to thank all staff for remaining vigilant to potential threats to our information security.

RECENT UPDATES

Bluebeam

In the past year, Community and Economic Development has prioritized enhancing the efficiency and accessibility of our permitting systems. Through a concerted effort, we have implemented strategic measures to streamline processes and transition towards online submittals. We now have 40 permits available online and will continue to add additional permits throughout the next year.

Bluebeam, a construction software that is used to assist permit reviewers review plans in real time and manage plan check projects, will be live next week to review e-plan sets for building permits. It is easier to submit, manage, and track than paper plans for a streamlined review process.

This initiative reflects our commitment to providing a more seamless and user-friendly experience for all stakeholders involved in the permitting process. As our department actively strives to improve and modernize our permitting processes, we acknowledge that this transition may encounter occasional technology glitches. We appreciate the understanding and patience of our stakeholders during this period of enhancement.

The Division is in the beginning stage of hiring for the Associate Plan Check Engineer. This recruitment will provide a stable plan check service and Code questions both at the counter and in the backroom.

HOUSING

Housing Rehabilitation:

A Home Improvement Project was completed on W. Gage Ave. The project consisted of a complete reroof, new concrete patio, patio cover, exterior and interior paint, ADA compliance, and code items.

Loan repayments for HOME and CDBG projects have been received in the amount of \$132,185.91. CDBG repayments will be put into the Home Improvement Revolving Account and used for future projects. HOME repayments will be put into the HOME General Fund account and be applied to future HOME-eligible projects.

Emergency Rental Assistance Program (ERAP)

Funding is still available through the Emergency Rental Assistance Program (ERAP) for residents affected by COVID-19 and need rental assistance. Residents are encouraged to contact Noemi.Verhelst@cityoffullerton.com for an application and more information.

Tenant Based Rental Assistance (TBRA) and Home Improvement Program – Mobile Homes

In mid-January Housing staff will conduct a presentation with the senior residents of the two mobile home parks in the City. Both programs will be explained, and applications will be distributed to qualifying residents. Staff will assist any resident who may need help in completing the applications.

Community Development Block Grant (CDBG)

A technical (mandatory) meeting for all non-profits interested in applying for 2024-2025 CDBG funding was held on Tuesday, October 17. Twenty-two representatives from eighteen agencies attended. Noise Ordinance Amendments to Chapters 3 and 15 were approved by the Planning Commission on November 22nd. The item will be presented to the City Council on December 19, 2023.

1500 South Raymond, previous Hotel Fullerton site, the project was approved by the Planning Commission on November 22nd for a new 138,419 square foot industrial building for warehousing/distribution/office uses and will be developed by Rexford Industrial.

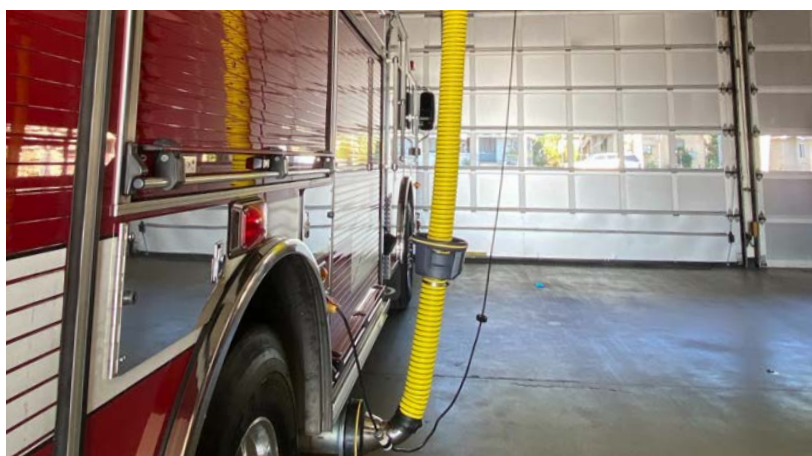

FIRE DEPARTMENT

SOURCE CAPTURE EXHAUST

The Fullerton Fire Department completed the installation of a Source Capture Exhaust Extraction System (SCES) at Fire Stations 1, 3, and 6. A SCES is a system where exhaust gasses from an apparatus or vehicle are captured directly via a device that attaches to the vehicle's exhaust pipe. The gasses are then released through the conduit device to the exterior of the building, thus preventing the exhaust from being inhaled by firefighters, fire personnel, and visitors to the station. According to the National Institute for Occupational Safety and Health (NIOSH), firefighters face a 9 percent increase in cancer diagnosis and a 14 percent increase in cancer-related deaths compared to the general population of the U.S.

Over the past two years, the Fullerton Fire Department has upgraded SCES Systems at all fire stations because of FEMA's Assistance to Firefighters Grant (AFG) Program grant awards.

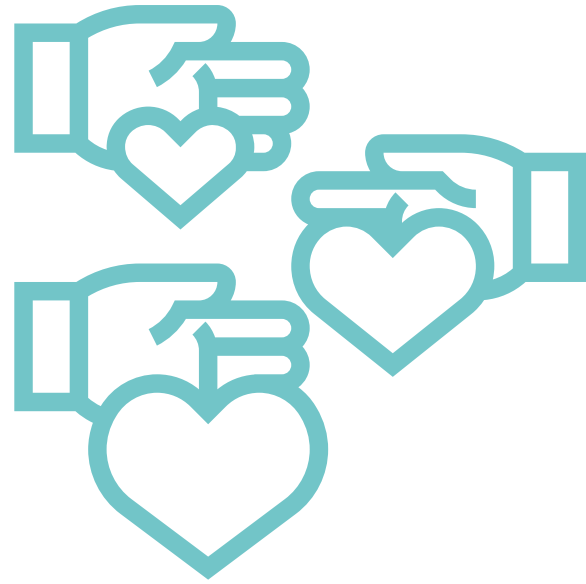

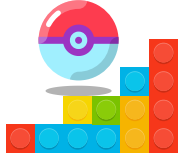

After months of planning and collaboration, we were happy to announce the ribbon-cutting ceremony for the brand-new playground at Acacia Park. The much-anticipated opening of the park took place on December 2nd at 10 am, marking a significant milestone in our commitment to enhancing the recreational space at Acacia Park.

The journey to that moment began with careful consideration and significant community input. We received over 200 survey responses with feedback during the community meetings that played a crucial role in shaping the design. The new playground promises to be a source of delight and inspiration for children and families alike.

POOCH PARK UPDATE

Staff recently met with the Pooch Park Foundation to discuss improvements to the existing facility, gather input on current needs, and address concerns regarding the current park. Staff presented the foundation with conceptual renderings of potential Pooch Park relocation sights, including Brea Dam Park and White Park. A Pooch Park relocation discussion will take place at the upcoming Parks and Recreation Commission meeting on December 11, 2023 at 6:30pm.

Recently, heavy winds resulted in a large tree limb falling on the west perimeter fence at Pooch Park. Staff has contracted with A1 Fencing to repair the fence in the coming weeks.

POLICE DEPARTMENT

HOLIDAY REMINDERS

We are well into the craziness of the holiday shopping season, and the Fullerton Police Department reminds everyone to use common sense and caution when having packages delivered at home.

Online shopping is convenient and fast. That said, most online packages are delivered to customers' doors, even if nobody is home to accept them.

Unfortunately, this also brings out no good porch pirates who are looking for crimes of opportunity, as well as criminals who target delivery trucks in neighborhoods. To reduce the chances of being victimized by package delivery thieves, the Fullerton Police Department offers the following advice:

- Choose shipping options that require a signature for delivery.
- Check the delivery status of your purchases online so that you can plan on someone being home to accept packages. Some retailers even offer text messages to your cell phone to alert you when items have been delivered.
- On the expected day of arrival, post a note on your door asking the delivery service to leave the package with a trusted neighbor, and don't forget to tell that neighbor to expect your package.
- Arrange to have the package shipped to another location where someone can receive it. Some P.O. Box stores will accept deliveries for a small fee.
- Ask the delivery company to hold your package for customer pick-up at their local shipping facility.
- If you do not receive your shipment on time, check with the company of origin and confirm the delivery. If the item was delivered and you did not receive it, report the theft or loss to the original company, the shipping company, and your local Police Department.

Many of these crimes occur during broad daylight. BE ALERT ABOUT SUSPICIOUS BEHAVIOR in your neighborhood. Get to know your neighbors so you can trust and rely on one another.

Remember, if you see suspicious activity in your neighborhood, take the time to get involved by simply reporting it. If you observe a crime in progress, call 9-1-1. If you can do so safely, get as much descriptive information as possible about the suspect(s) and/or vehicles, including the license plate, to aid Police in catching the criminals.

EUCLID & 91 UNDERPASS

The City of Fullerton in joint with the City of Anaheim and CalTrans have been coordinating efforts to beautify the Euclid and 91 underpass. Weather permitting, construction is scheduled to begin with the installation of a rock slope protection and other improvements on December 1st and to finish by Christmas.



SB 1383 PROCUREMENT TARGET COMPLIANCE



The City is set to reach one major milestone of Senate Bill 1383 (SB 1383) in relation to procuring recovered organic waste products to meet the Calendar Year 2023 compliance target. The Solid Waste and Recycling Team researched available qualifying procurement product options and considered the most beneficial and cost-effective method of compliance. Zero Foodprint will support the City's efforts towards SB 1383 procurement credit for compost use in agricultural and horticultural settings including all required reporting documentation. This is one step of the procurement requirement. City staff is evaluating procurement compliance target options for Calendar Year 2024 and sustainable practices annually thereafter.

SB 1383 EDIBLE FOOD RECOVERY COMPLIANCE

The Solid Waste and Recycling Team is beginning to make progress with SB 1383 Edible Food Recovery initial implementation tasks. To reduce food waste and help address food insecurity, SB 1383 requires that by 2025 California will recover 20 percent of edible food that would otherwise be sent to landfills, to feed people in need. The law directs jurisdictions to strengthen relationships between food donors and food recovery organizations, actively expand and create new infrastructure to grow food recovery networks.



To meet this goal, city staff is concentrating on identifying qualifying commercial edible food generators within the community and establishing an education and outreach program to support edible food donors in complying with their requirements. Food donors will have to establish contracts or written agreements with food recovery organizations and track the amount they donate by weight and maintain up-to-date records. Jurisdictions are required to educate food donors about these requirements and monitor their compliance through an enforcement and inspection program.

The City is planning to work in partnership with their Solid Waste Handling Services Contractor, Republic Services, to fully meet all Edible Food Recovery compliance regulations, upon finalization of the Fourth Contract Amendment.



PUBLIC WORKS



ENGINEERING

The CIP Division recently completed reconstruction of the historic Union Avenue Bridge. The original bridge was constructed in the 1930's and is considered a historic City structure that spans the Brea Creek Channel adjacent to Fullerton High School. A suspected drunk driver severely damaged the northerly bridge railing, resulting in the need to completely remove and reconstruct the railing. There are no available plans from the original construction, but the repair was required to match the original look and style. As such, the City partnered with a contractor who has extensive experience working on historic buildings and structures to determine the appropriate repair method and materials.
