SAVE THE DATE: COYOTE TOWN HALL



Fullerton residents and businesses are invited to attend an in-person Town Hall Discussion held in the City Council Chambers at Fullerton City Hall located at 303 West Commonwealth Avenue on **Monday**, **March 25**, **2024**, at 6:00 p.m.

This meeting is intended to provide an informational forum to learn more about coyote behavior, reporting, and

what community members can do to safely coexist with coyotes. A presentation will be provided by OC Animal Care and representatives from the California Department of Fish and Wildlife will be in attendance to answer questions and provide additional information.

UPDATE ON APPROPRIATIONS/PENDING FUNDING

On February 29th, the U.S. House of Representatives passed a continuing resolution (CR) to fund the government for a few more days, avoiding a shutdown that had been in line to occur the night of March 1st. The Senate passed the bill on a 77-13 vote shortly after the House acted, sending it to President Biden for his signature.

Under the deal, funding for Agriculture-FDA, Energy and Water, Military Construction-VA, Transportation-HUD, Commerce-Justice-Science and Interior-Environment are extended to March 8th. Whereas Defense, Financial Services-General Government, Homeland Security, Labor-HHS-Education, Legislative Branch, and State-Foreign Operations are extended to March 22.


Under the parameters of the deal reached, two six-bill packages will come to the floor of the House this month. When Congress returns to Washington, DC on March 4th we anticipate action will be taken on the first package of bills, with action on the second coming during the week of March 18th.

What does this mean for Fullerton? All three of our below pending earmarks would be included in the first package of bills:

- 1. THUD Police Station Historic Remediation and Rehabilitation Project for \$2.5 million submitted by Rep. Steel.
- 2. THUD Police Station Historic Remediation and Rehabilitation Project for \$1 million submitted by Rep. Correa.
- 3. Interior Well 7A Construction Project for \$959,752 submitted by Rep. Correa.

CITY CLERK UPDATES


The City Clerk's Office received 20 public records requests and closed 17 public records requests since March 1st with an average close of 10.14 days.





PC Refresh Underway

We are continuing to update the City's end-user PC environment. This year, 57 desktop PCs were identified as reaching end-of-life and are approved to be replaced with new Dell models. Users with devices on this list are being contacted so that their replacement can be scheduled. So far, 29 have been deployed. The upgrade should be complete by the end of April.

We are at the final stage of hiring process for the Associate Plan Check Engineer position. This recruitment will provide a stable plan check service and provide answers to code related questions both at the counter and in the backroom.

HOUSING

The new Housing Manager, Dan Valdez, was introduced to The Community Development Citizens Committee (CDCC). Dan shared his previous experience and enthusiasm in joining the "Fullerton Family". He looks forward to working with the committee and serving the community.

Community Development Block Grant (CDBG)

The Community Development Citizens' Committee (CDCC) held its third meeting on February 27. The committee heard from the Fair Housing Foundation, Special Code Enforcement, Parks and Recreation –Union Pacific Park improvements and Community and Economic Development Housing Rehabilitation.

Hope Center

The Housing staff met with Hope Center Executive Director for a meet and greet to talk about homeless outreach and proactive engagement. The Housing team has been invited to monthly meetings every second Tuesday of the month with North Orange County stakeholders.

Tenant Based Rental Assistance

The Housing Division completed annual recertifications for 16 clients at Rancho Fullerton and Rancho La Paz. Recertifications are meant to update client's annual income and ensure units meet Housing Quality Standards inspections, per HOME requirements.

Housing Rehabilitation

We successfully completed two roof replacements forgivable and emergency loans on W. Valencia Ave. and S. Pacific Dr. We are actively engaged in another roof replacement project on E. Elm Ave. Additionally, there are two forgivable loan projects in the bidding phase set to close by 3/14/2024.

PLANNING

The Planning Division is pleased to announce the addition of Senior Planner David Lopez, who started with the City last week. David was previously employed at the City of La Habra, where he worked his way up through the ranks starting off as an intern, counter tech, Assistant Planner, and then Associate Planner. 
WORLD WATER DAY

ENGINEERING: STREET REHABILITATION PROJECTS

Associated Road

The second phase of Associated Road Rehabilitation is nearing full completion with only minor punchlist items remaining. The roadway paving and new striping was installed over the past couple of weeks.

State College Boulevard

The City will be receiving approximately \$1.3 million of Federal funds for the State College Boulevard Project (Yorba Linda Blvd to north city limits). Two years ago, Public Works staff requested repurposing project savings from the State College Railroad Grade Separation Project to assist with rehabilitation of State College Boulevard. This request was recently approved by the Federal Highway Administration (FHWA) and will help offset the construction costs. The project is in design but award of the Federal funds will delay construction activities as we address the federal funding requirements for bidding and construction.

Pavement Treatment Project

Over the past year, the City successfully completed pilot pavement treatment projects on Hillcrest Place (see pictures below), Lincoln Avenue and Burning Tree Road using an enhancement slurry seal produced by Petrochem Materials Innovation (PMI). PMI has a new formula and has approached the City to donate this product on two small length (200') streets. Staff is currently finalizing the details of this donation which will be completed at no cost to the City for materials or labor. The two streets proposed for treatment are Santa Clara Place cul-de-sac and Mission Avenue, both near Chapman Park.

SOLID WASTE & RECYCLING TEAM

SB 1383 Corrective Action Plan Compliance Efforts

The Solid Waste and Recycling (SW&R) Team continues focusing on SB 1383 CalRecycle Corrective Action Plan (CAP) compliance efforts. The Fullerton CAP #4 Report was submitted on November 30, 2023. An extension request for twenty-five (25) tasks was also included in the report and approved. The Fullerton CAP #5 Report was submitted by the State's January 31, 2024, deadline along with an extension request for thirteen (13) tasks, for which the City is awaiting confirmation of approval. The CAP contains seventy-three (73) tasks for completion. City staff has completed sixty (60) tasks, and the remaining tasks are reliant on the finalization of the contract amendment with the City's Solid Waste Handling Service Provider, Republic Services. The State's Enforcement Branch Representative favorably acknowledges the efforts made by the City within the past year since the CAP was established and is agreeable to working cooperatively with the City to complete the final portion of regulation compliance.

SB 1383 Local Assistance Grant Program Grant FY 2022-2023 Award

The City's Solid Waste and Recycling Specialist submitted an application for the SB 1383 Local Assistance Grant Program Fiscal Year 2022–23 additional round of funding. The eligible grant funds for the City of Fullerton were initially estimated to be \$252,763. City staff was notified of the grant award on February 26, 2024. The final award amount was established to be \$378,021. Funds are expected to be received sometime in Spring 2024. The SW&R staff have budgeted the funds to aid in regulation compliance with tasks related to Capacity Planning, Collection Services, Education and Outreach, and Procurement requirements.
